PLEASE CAREFULLY READ THE NOTES AND INSTRUCTIONS ON THIS PAGE BEFORE SUBMITTING PAGE TWO OF THIS FORM TO THE FINANCIAL AID OFFICE.

Use this form ONLY if you do NOT want to accept loan funds for equal amounts in the fall and spring semesters OR if you have previously declined loans you now want to accept.

To accept offered loans for equal amounts in fall and spring (or single semester loan offers), login to your MyNS Student Center, select Accept/Decline Awards, indicate your choice and submit. If you select "Accept" you will then have an option to reduce the amount you would like to accept.

PLEASE NOTE

- **You must be enrolled at least half-time at NS to receive loans.**
 - For Freshmen, Sophomores, Juniors and Seniors that is at least 6 financial aid eligible credits.
 - For Master's level students that is at least 5 financial aid eligible credits.
- **Decrease** requests can only be processed for loans for which a refund has NOT been generated. If you wish to reduce or cancel a loan for which a refund has been generated, please contact the NS Financial Aid office.
- For loan **increase** requests, there are maximum annual and lifetime loan limits, as well as other eligibility criteria, which may prevent us from awarding you the full amount you request. We will award as much as possible based on your eligibility.
- Federal Regulations require completion of **Entrance Loan Counseling** and a **Master Promissory Note** at www.studentloans.gov before loan funds can be disbursed. If **Financial Awareness Counseling** is on your MyNS To Do List, you must complete that before loans can be disbursed.
- Loan amounts must be at least \$50 and must be whole dollar amounts (no cents).

- Check the box(es) and fill in the blank(s) on page 2 of this form to indicate how you would like your loans adjusted.
- When you fill in the amount, indicate the TOTAL amount you want for each term and each loan type.

EXAMPLES

- **Increase example:** You already accepted \$500 in Subsidized Loan for the fall 2024 semester. To request \$1,000 more in subsidized loan for the fall 2024 semester, you would put \$1,500 in the blank (\$500 already accepted plus \$1,000 additional requested)
- **Decrease example:** You originally accepted \$1,750 in Subsidized Loan for the fall 2024 semester, but the loan funds have not yet paid out and you have decided you only want \$1,000 in Subsidized Loan for the fall 2024 semester. You would put \$1,000 in the blank below in the Subsidized Loan section for Fall 2024.
