## **HOUSING CHANGE REQUEST FORM FAQ's**

### Who should fill out this form?

NS Financial Aid must develop a "budget" for each student who is awarded financial aid.

- The standard budget, also called the estimated cost of attendance (COA), includes allowances
  for tuition and fees, books, supplies, travel, miscellaneous/personal expenses, food, and
  housing.
- Since housing information is no longer provided on the FAFSA®, NS Financial Aid assigns a housing status based on available information.
- If your housing situation is different than what is currently listed on your NS financial aid record, you can submit this form to request a review of the housing component of your budget.

## Will I get more financial aid if I complete this form?

Changing your housing status does NOT guarantee you more financial aid, it only changes your estimated costs.

- If the estimated cost for the new housing type is higher, then you may be eligible for more financial aid.
- A change in housing status could also REDUCE your estimated costs and potentially reduce your eligibility for financial aid.
- If you are not sure if a change to your housing status could benefit you, please contact our office so we can look at your eligibility.
